These conditions of sale are concluded on the one hand by the company Dive and Cruise Limited. Registered Capital of 50,000 euros, registered office is at: **Room 1206-7 12 / F, New Victory House, 93-103 Wing Lok St, Central, HONG KONG**, registered with the Trade and Companies under Hong Kong number **1434283** hereinafter "Dive and Cruise Limited" and secondly, by any person or entity wishing to make a purchase via the website of "Dive and Cruise Limited" hereinafter called "the purchaser".

1. Object

These conditions of sale are intended to define the contractual relationship between Dive And Cruise Limited. the purchaser and conditions applicable to all purchases made through the merchant site Dive And Cruises Limited. that the buyer either professional or consumer. The acquisition of property or services through this site implies acceptance by the buyer of these conditions of sale.

These conditions shall prevail over any other general or special conditions not specifically approved by Dive and Cruise Limited. Dive and Cruise Limited. reserves the right to modify the conditions of sale at any time. In this case, the conditions will be those in force at the date of the order by the buyer.

2. Characteristics of goods and services

The products and services offered are those listed in the catalog published on the site of Dive And Cruise Limited. These products and services are offered within the limits of available stocks. Each product is accompanied by a description provided by the supplier.

The photographs in the catalog are as accurate as possible but can not ensure a perfect similarity with the product, especially with regard to color.

3. Rates

The prices listed in the catalog are inclusive price in Euro or U.S. \$ in order to give an idea of the price as close to reality as possible. The actual price is recalculated at the time of editing our Proforma using the site www.xe.com; any change in the rates of different market (THB - Thailand / RM - Malaysia / IDR - Indonesia / PHP - Philippines) be reflected in the price of goods or services. Dive and Cruise Limited. reserves the right to change prices at any time, except that the price discussed in our exchanges Internet (internet messaging and / or real-time chat) will be applicable only to the buyer. The prices include the cost of order processing, transportation and delivery, international transfer in the proposed geographic area on our website.

4. Orders

The buyer, who wishes to buy a product or service must:

- Fill in the form of identification which show all the data requested;
- Complete the order form "Proforma with indications of date and agreed" with his signature to validate his command after having checked it;

- Make payment as required.
- The confirmation of the order after the first payment where applicable involves acceptance of these terms of sale, the recognition of having perfect knowledge and renunciation to rely on its own terms of purchase or other conditions. All data recorded and confirmed valid proof of the transaction. Confirmation worth signing and acceptance of transactions. The seller will email confirming the order recorded.

5. Retraction

The buyers, non-professional individuals, benefit from a period of seven days after their signature on the proforma sent by Dive And Cruise Limited to cancel without charge. The rebate in this period of seven days does not lead to penalty, except the cost of return set at 15 € per bank transfer. The terms of payment and the price is due upon ordering.

6. Payments:

Payments will be made by credit card or by bank transfer (SWIFT or SEPA)

6.1 Bankcard

they will be made through the secure PayPal system which uses SSL (Secure Socket Layer) such that the transmitted information is encrypted by software and no third party can read in transit on the network. Payment by credit card via the PayPal website is subject to a tax of 3.4% of the amount to be paid.

6.2 Transfer

Dive and Cruise Limited put his various accounts available to its customers, for the sake of conveniences in terms of geographical location called "buyers". The corporate account at HSBC bank as our preferred choice to receive the transfer in Euros, USD, GBP, THB, CHF We have also personal accounts from our executives (France - Switzerland - Italy) available to buyers if that is more practical ..

7. Deliveries

Deliveries are made to the address specified in the order that can only be in the area agreed. The risks are taken by the purchaser at the time the goods have left the premises of Dive And Cruise Limited.

In case of damage during transport, the complaint must be made with the carrier within three days after delivery. Delivery times are only indicative and if they exceed sixty days after the order, the contract of sale may be rescinded and the buyer reimbursed.

8. Guarantee

All products supplied by the seller benefit from the legal guarantee provided by Article 1641 of the Civil Code. In case of non-compliance of a product sold, it can be returned to the vendor who will exchange or refund. All complaints, requests for exchange or refund must be made via the Internet at the following address: reclamation@dive-and-cruise.com within 15 days after delivery.

9. Responsibility

The seller, in the process of selling online is only bound by an obligation of means, his liability can

not be held liable for damages resulting from the use of the Internet such as data loss, hacking, viruses, break service, or other unintended problems. Intellectual Property All elements of the site Dive And Cruise Limited. are and remain the exclusive intellectual property of Dive And Cruise Limited and operators have signed a contract with them.

Nobody is allowed to reproduce, use, repost, or use for any purpose whatever, even partially, the elements of the site they are software, video or audio. Any single link or hyperlink is strictly prohibited without express written permission of Dive and Cruises Limited.

10. Personal data

According to the law relating to data, files and freedoms of January 6, 1978, the information containing names of buyers may be subject to automated processing. Dive and Cruise Limited. reserves the right to collect information on purchasers including using cookies, and, if desired, to transmit to business partners collected information.

The buyers may object to the disclosure of their details by notifying Dive And Cruise Limited. Similarly, the users have the right to access and correct data concerning them, according to the law of January 6, 1978.

11. Filing - Proof

Dive and Cruise Limited. archive purchase orders and invoices on a reliable and sustainable as a true copy under the provisions of section 1348 of the Civil Code. The computerized records of Dive And Cruise Limited. will be considered by the parties as proof of communications, orders, payments and other transactions between the parties.

12. Dispute Resolution

These conditions of online sales are subject to the law of Hong Kong. In case of dispute, jurisdiction is assigned to the competent courts of Hong Kong, despite multiple defendants or third parties.
